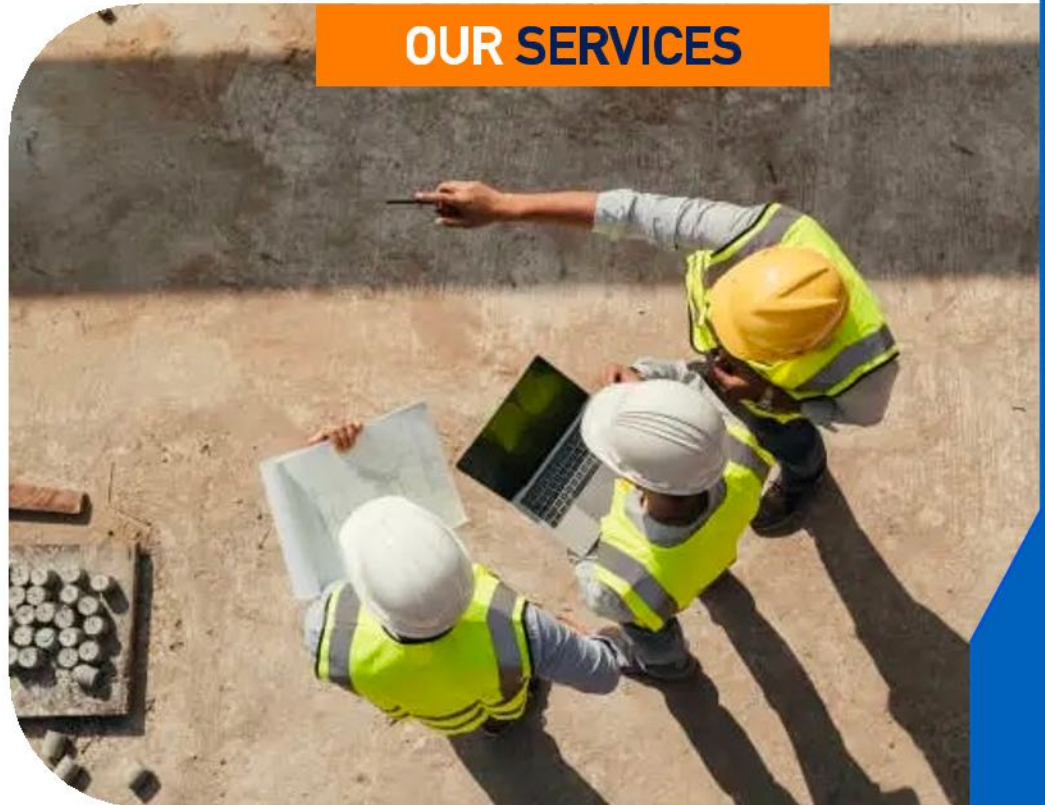
MELABCO – Company Organizational Chart

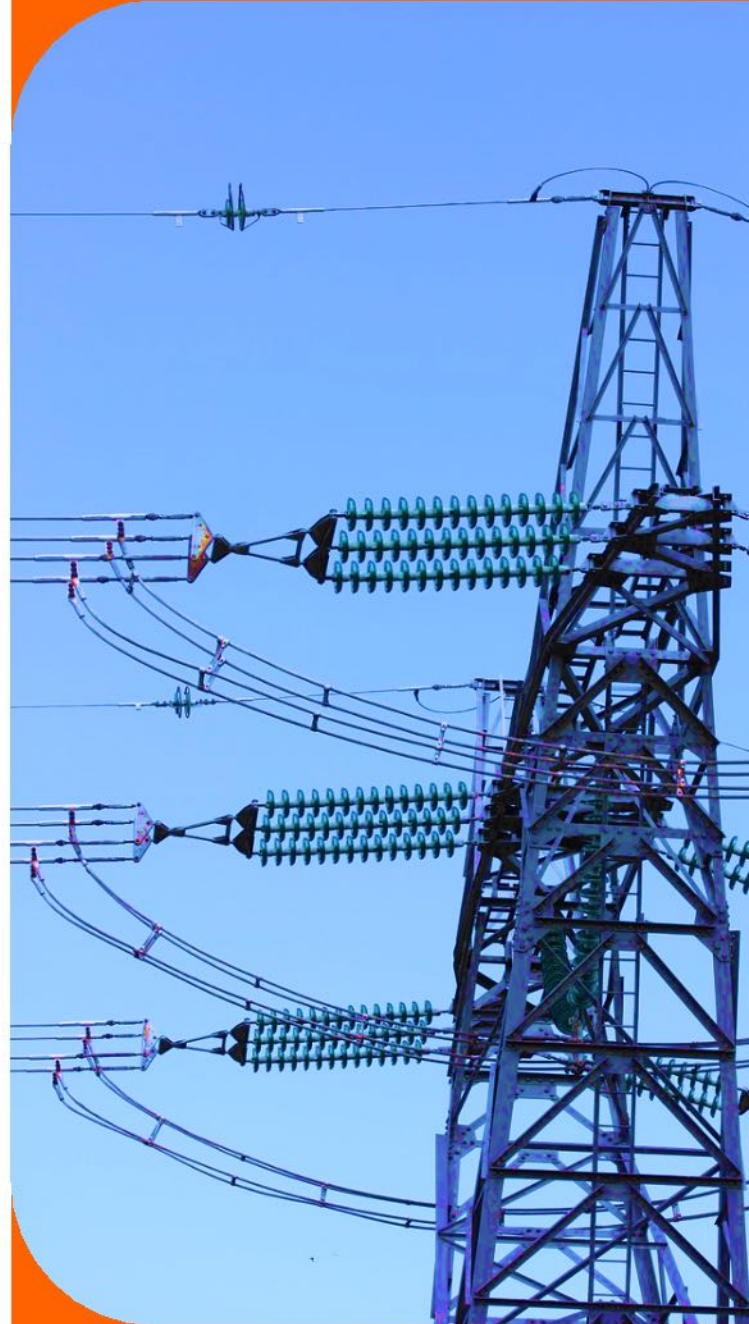
OIL FIELD CONSTRUCTION EXPERTISE

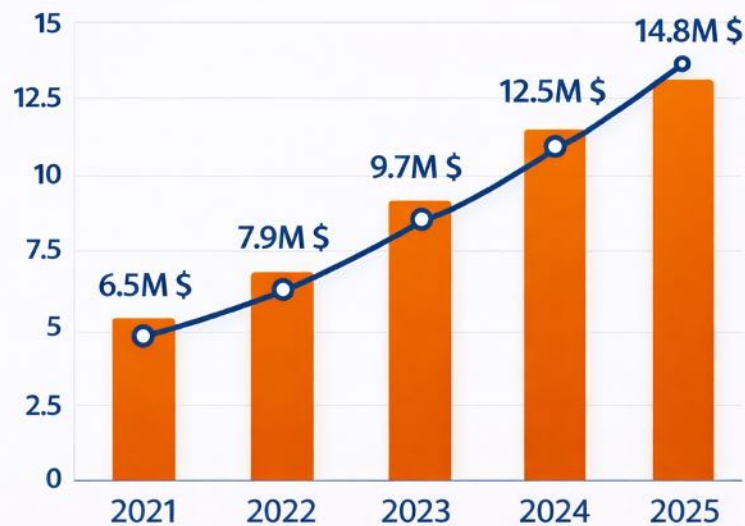

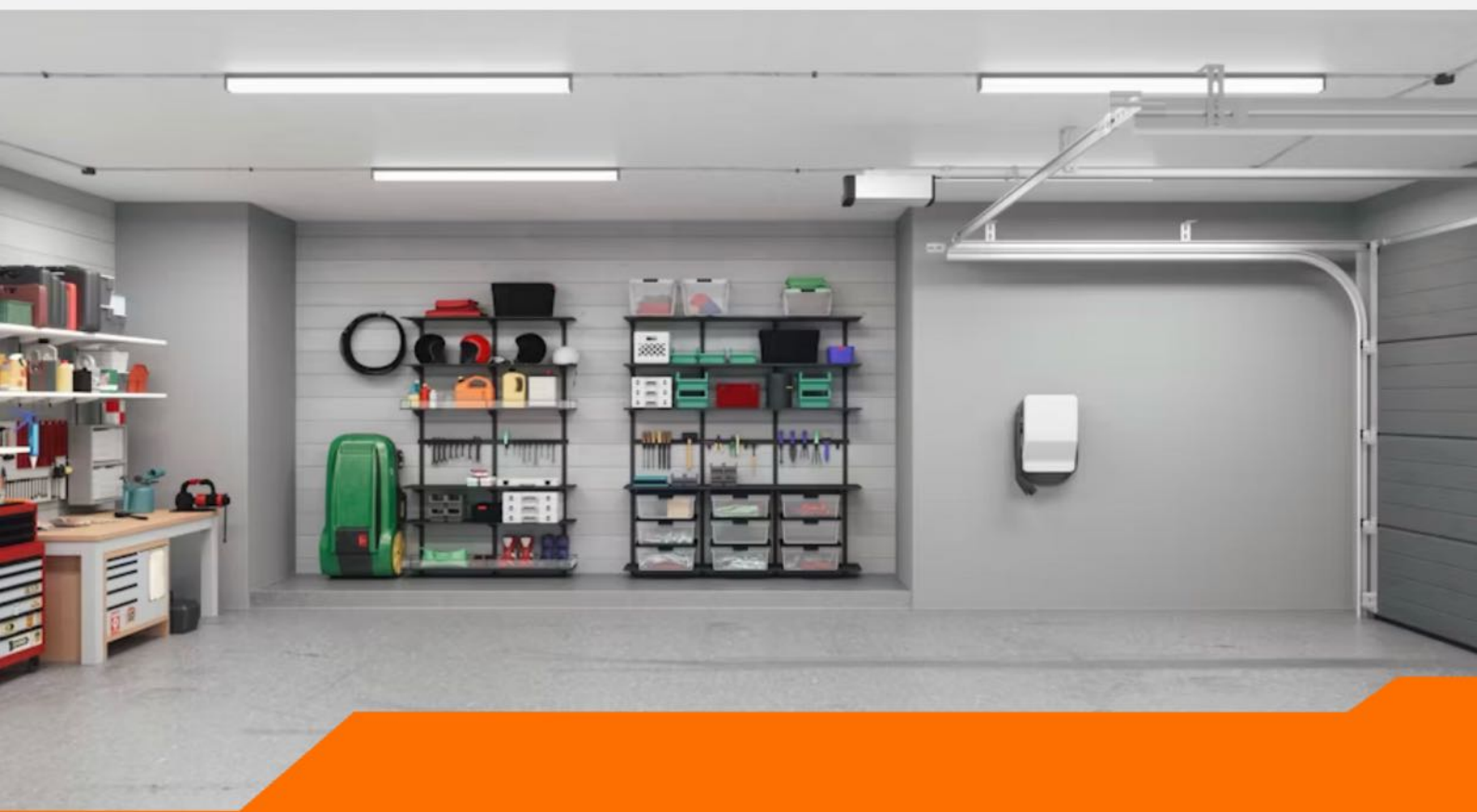
3. Heavy Machinery & Specialized Units
